



PUBLIC OFFER  
for the Provision of Pre-press Services

I. Declaration and Accessibility

This document constitutes a public offer by the Contractor to enter into an agreement for the provision of pre-press services (hereinafter — the Agreement).

Acceptance of the offer by a natural or legal person shall constitute the conclusion of the Agreement on the terms set out herein; such person thereby acquires the status of the Client (Article 638 of the Civil Code of Ukraine).

II. Description of Services

The Contractor provides the Client with editorial services, including editing, pre-press preparation, electronic layout, publication of materials on the journal's website, and archiving of scientific and/or other texts.

The provision of services commences only after receiving all positive peer reviews confirming the possibility of publishing the article in the journal.

By accepting this offer, the user confirms agreement with the terms of the Agreement and the privacy policy and unconditionally undertakes to comply with them.

III. Accession to the Agreement

The Agreement is concluded by the Client's full and unconditional accession to its terms.

The moment of acceptance shall be deemed the Client's first submission of scientific and/or other texts to the official e-mail address of the Editorial Office.

IV. Procedure for Interaction Between the Parties

The Editorial Office (the Contractor) accepts manuscripts intended for publication in printed media on a gratuitous basis.

Client's obligations:

- to send the manuscript to the official e-mail address of the Editorial Office;
- to provide information and take actions, upon request, which the Editorial Office reasonably considers necessary and sufficient for the proper fulfilment of the order.

V. Timeframes and Result

The standard period for service provision is up to four (4) months from the date of acceptance; in exceptional cases, the period may be individually agreed with the Client.

Services shall be deemed rendered, and the Contractor's obligations fulfilled, upon approval by the Editor-in-Chief of the final layout of the issue containing the Client's material.

VI. Financial Terms

Services are provided free of charge; no payments from the Client are envisaged under this Agreement.

VII. Validity of the Offer and Duration of the Agreement

This offer takes effect from the moment of its publication online at the address specified in Section I, paragraph 3, and remains valid until revoked by the Contractor.

The Agreement becomes effective upon acceptance by the Client and remains in force until both Parties have fully fulfilled their obligations.

The Agreement may be terminated early by mutual consent of the Parties.

The offer is not irrevocable; the Editorial Office reserves the right to refuse to provide services to persons who do not agree with its terms.

VIII. Personal Data

By entering into this Agreement, the Parties grant each other the right and consent to the indefinite processing of personal data in accordance with the Law of Ukraine “On Personal Data Protection”.

The use and dissemination of personal data shall be limited to the scope necessary to ensure the activities and/or protect the interests of the Parties and to perform this Agreement.

IX. Liability and Dispute Resolution

For non-performance or improper performance of this Agreement, the Parties shall bear liability in accordance with the applicable legislation of Ukraine.

Disputes and disagreements shall be settled through negotiations; if no agreement is reached, they shall be resolved in court.
